The mission of the Bear River Land Conservancy is to conserve and enhance private lands for wildlife habitat, working farms and ranches, land and trails of recreational or historical significance, watersheds, and critical vistas, using conservation easements and sound management, to benefit the people of northern Utah, today and in perpetuity.

"Land Protection" included: 1) working with private landowners to apply for funding to protect private lands that provide public values, 2) applying for funding from various grant programs to protect and steward other private lands, 3) developing a strategic conservation plan to guide the organization toward the most important lands for conservation.

"Stewardship" included: 1) managing the 455 acre Bear River Bottoms conservation easement, including planting native plants for wildlife habitat, monitoring this property and adjacent properties for weed infestations, monitoring for compliance with restrictions outlined in the easement document, managing grazing leases used to control weeds and invasive native vegetation, securing boundaries, planning for future management, and working with private and public entities to establish wetland mitigation projects on this easement consistent with the site management plan; 2) monitoring a 3 acre conservation easement for compliance with restrictions outlined in the easement document; 3) managing a 30 acre fee property that is owned and managed to protect a threatened species of orchid and for its open space values. "Revenue" came from grazing leases used to manage vegetation at the Bear River Bottoms and support open space values associated with agriculture.
